Initial Term

Coextensive with the current Initial Term or Further Term applicable to the Access software product to which our Access Group Payments product is attached.

Consequently, any renewal or termination of the term of the Software Product shall automatically apply to this Payment Product.

Customer Support

In line with your Customer Support Plan for the software product to which this Payments component applies.

Payout (to You) Terms

Following the Transaction Date, Stripe, our third party partner, will automatically initiate a payout of Proceeds, normally received within 3 Business Days to your nominated bank account or as varied by conditions communicated with You.

Australian Consumer Law

The parties acknowledge that this agreement is subject to the Australian Consumer Law as set out in Schedule 2 of the Competition and Consumer Act 2010 (Cth) and any corresponding state or territory consumer protection legislation. Nothing in this agreement excludes, restricts or modifies any consumer guarantee, right or remedy conferred by the Australian Consumer Law or any other applicable consumer protection law that cannot be excluded, restricted or modified by agreement. To the extent permitted by law, the liability by Access for any breach of a consumer guarantee relating to the supply of services is limited to, at Access's option: (a) the supply of the services again; or (b) payment of the cost of having the services supplied again.
